

## 2020 Notice of Tax Rates in CITY OF HARLINGEN

Property Tax Rates in CITY OF HARLINGEN. This notice concerns the 2020 property tax rates for CITY OF HARLINGEN. This notice provides information about two tax rates. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. The voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

### This year's no-new-revenue tax rate:

Last year's adjusted taxes (after subtracting taxes on lost property)	\$19,061,584
This year's adjusted taxable value (after subtracting value of new property)	\$3,169,355,835
=This year's no-new-revenue tax rate	0.601434/\$100
+This year's adjustments to the no-new-revenue tax rate	\$0 /\$100
=This year's adjusted no-new-revenue tax rate	0.601434/\$100

**This is the maximum rate the taxing unit can propose unless it publishes notice and holds a public hearing as provided by the Texas Tax Code.**

### This year's voter-approval tax rate:
