Workforce Wednesday Job Fair, Feb. 9**

Harlingen, Texas (Jan. 25, 2022) – The City of Harlingen, Harlingen EDC, and Workforce Solutions Cameron will be hosting the fourth Workforce Wednesday Job Fair on Wednesday, Feb. 9 from 9 a.m. to 12 p.m., at Casa de Amistad, 1204 Fair Park Blvd., Harlingen.
