**MASS DRIVE-THRU VACCINATION CLINIC TO OPEN ONLY FOR INDIVIDUALS
65 YEARS OF AGE AND OLDER IN CAMERON COUNTY**

Cameron County will host a drive- thru COVID-19 vaccination clinic on Friday, January 29, 2021, at the Los Fresnos Fire Department located at 100 Rodeo Dr. (off of State Highway 100) in Los Fresnos. Cameron County's priority at this time is to vaccinate those individuals 65 years of age and above with the Moderna vaccine.

According to the Special Populations Data provided by the Centers for Disease Control and Prevention, individuals 65 through 74 years of age are 5 times at a greater risk to be hospitalized, individuals 75 through 84 years of age are 8 times at a greater risk, and individuals 85 plus years of age are 13 times at a greater risk. Cameron County Public Health has partnered with school districts in Cameron County to administer the vaccines. This vaccination clinic will begin at 6:00 a.m. and continue until supplies last. All persons must be in line no later than 12:00 p.m. and information and vouchers will be verified on site. The public is asked to please remain in your vehicle upon arrival and complete the consent and registration form ahead of time to expedite this process. No walk-ins will be allowed.

It is expected that Cameron County Public Health will receive additional COVID-19 vaccines in future weeks and will provide additional vaccination clinic updates as allocations are confirmed. Cameron County is dedicated to administering COVID-19 vaccines in accordance with the guidance from the State of Texas and will provide updates as vaccination are made available.
